



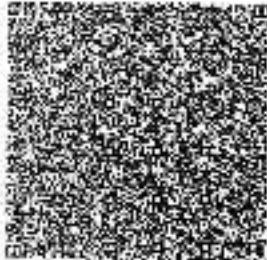

SERVICE AGREEMENT

THIS AGREEMENT made at Delhi on this 1st May day of 2018

BETWEEN

M/s Stalwart Security Services India Limited, a Company incorporated under the Companies Act and having its registered office at 41/1, Neer Maniyakarar Street, Ramanathapuram, Coimbatore-641 045 and regional Office: Flat No.-101, Building No.-09, Allied Bhawan, LSC, Madangir, New Delhi-110062 hereinafter referred to as "the Service Provider" through its authorized representative Mr. Vinod Kumar Mishra (which term shall so far as the context admits be deemed to mean and include its principals, subsidiaries affiliates and their successors and assigns) of the ONE PART;

AND

M/s Schenker India Pvt Ltd, a Company incorporated under the Companies Act and having its registered office at 217, Second Floor, Vardhman, Crown Mall, Plot No. 02, L.S.C, Sector 19, Dwarka, New Delhi-110 075, hereinafter referred to as the "Company" (which term shall so far as the context admits be deemed to mean and include its divisions, subsidiaries affiliates and their successors and assigns) of the OTHER PART;
